Dear colleagues,

With the new year around the corner, this last newsletter for 2023 presents you with a very recent highlight and a perspective of an important event in 2024.

At the International Science Data Week 2023 in Salzburg this October, CESSDA ERIC and CODATA, the Committee on Data of the International Science Council (ISC), have formalised a strategic partnership through the signing of a Memorandum of Understanding. The collaborative venture stems from a shared recognition that addressing major global challenges necessitates robust and trusted research infrastructures cutting across societal, ecological, and economic domains, recognizing the pivotal role of social sciences data.

The signing of the MoU coincided with the selection process of a new President for CODATA. Mercè Crosas, head of Computational Social Sciences at the Barcelona Supercomputing Centre was elected for a five-year mandate. Mercè has an impressive career with experiences as Secretary of Open Government for the Government of Catalonia, Chief Data Science & Technology Officer at Harvard's Institute for Quantitative Social Science and as the University-wide Research Data Management Officer, where she co-authored the FAIR data principles. CESSDA is looking very much forward to collaborating with Mercè Rosas and Simon Hodson, CEO of CODATA.

In 2024 CESSDA will organise its first conference in Split, Croatia to celebrate the 10th anniversary of CESSDA's Main Office.
