Welcome to the CESSDAs Newsletter 2025!



As of writing the editorial of the first 2025 CESSDA newsletter, three new ERICs in the field of physics, digital humanities and heritage science were established: CTAO, EHRI and E-RIHS.

On 7 January 2025, the **Cherenkov Telescope Array Observatory** (CTAO) was established to become the world's largest and most powerful observatory for gamma-ray astronomy. On 19 February, the **European Holocaust Research Infrastructure** (EHRI) became an ERIC to

advance trans-national Holocaust research addressing the field's challenge, which is the wide dispersal of sources and expertise across Europe and beyond. And on 28 March, E-RIHS, the **European Research Infrastructure for Heritage Science**, was created to support the research community on heritage interpretation, preservation, documentation, innovation and management.

The number of ERICs now amounts to 31, making the research infrastructure community more rich, but also more complex.

To contribute to navigate in such an increasingly diversified research landscape, CESSDA produced a set of new publications. A **Data Citation Guide** with practical recommendations tailored to key stakeholders, second a report on the current **open data landscape** contributing to the ongoing discussions on FAIR and European Open Science Cloud (EOSC). Finally, a brief entitled "**Top 5 Key Performance Indicators**". The brief showcases the progress made by CESSDA's 22 national social science data archives in the period of 2020-2022.

CESSDA aims to support social science data archives in improving practices, fostering collaboration, and enhancing contributions to the research community. In this context the

CESSDA consortium and partners were actively involved in the preparation the **BRIDGE conference** in Bucharest organised by the Director of Romanian Social Data Archive (RODA) and the Executive Agency for Higher Education, Research, Development and Innovation Funding (UEFISCDI) with support of the EEA and Norway Grants research programme.

In terms of outreach to research communities, I was invited as solicited speakers at the **European Geosciences Union (EGU)** in Vienna to discuss the exchange of data from the social sciences and the environmental sciences. The session was well visited showcasing the interest in blending data from different disciplines.

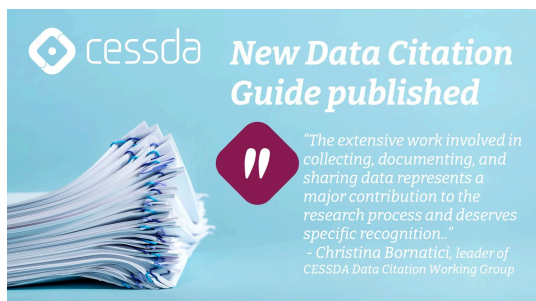
CESSDA Releases Brief on Advancing Trust in the Social Science Data Ecosystem

CESSDA published a brief entitled “The battle for trust: Advancing the social science data ecosystem”. The brief presents a comprehensive overview of the open data landscape from the perspective of European social science data archives. It highlights the importance of trustworthy repositories, the European Open Science Cloud (EOSC) Federation, other EU initiatives, as well as CESSDA's contribution to advancing



open science. The findings offer key takeaways for stakeholders such as funders, research infrastructures, data repositories, and researchers, aiming to promote open data practices and maximise the societal impact of long-term data preservation.

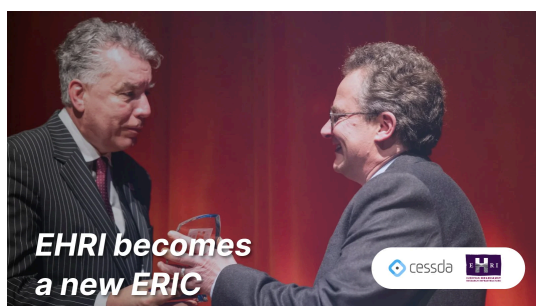
New CESSDA Data Citation Guide

repositories, authors, academic journals and publishers, Research Performing Organisations (RPOs), policy, strategy, and funding entities, and ethics committees.

CESSDA in the European Landscape



EHRI and E-RIHS become new ERICS in the Humanities and Social Sciences

In early 2025, two research infrastructures in the Humanities and Social Sciences Cluster were granted the legal status of European Research Infrastructure

Consortium (ERIC) by the European Commission — marking major milestones for both fields.

On 20 January, the [European Holocaust Research Infrastructure](#) (EHRI) became the 30th ERIC overall and the 6th in the social sciences and humanities. EHRI is the only permanent transnational organisation dedicated to Holocaust research, bridging fragmented archival sources, supporting preservation, and highlighting the societal relevance of Holocaust studies in today's world.

Just months later, on 28 March, the [European Research Infrastructure for Heritage Science](#) (E-RIHS) also became an ERIC. E-RIHS connects diverse disciplines — arts, humanities, sciences, and engineering — to advance research and innovation in heritage science. Its mission is to enhance the understanding, conservation, and sustainable use of cultural heritage across Europe and beyond.

Together, EHRI and E-RIHS mark a strong start to 2025 for the HSS Cluster and reaffirm the importance of collaborative, cross-border research in understanding and preserving Europe's complex history and cultural legacy.

First OSCARS Annual General Meeting held in Rome

[OSCARS](#) is a four-year Horizon Europe project designed to accelerate the uptake of Open Science across Europe. On 3-4 March, the OSCARS consortium, its funded projects and Science Cluster representatives gathered in Rome for a two-day conference to network and for strategic discussions and planning. Sixty-eight participants were present, including CESSDA director Bonnie Wolff-Boenish, while nearly forty attended online.



During the seminar, the key milestones of the work packages were presented, and the plan for the coming year was laid out. Funded projects gave short “flash talks” on their progress, and participants could browse an interactive world café, providing an opportunity for structured discussions in an informal setting.

Crossing the disciplines - CESSDA at EGU

CESSDA's Director was invited as solicited speakers for a [session on how to merge social science and environmental Studies](#) at the annual [General Assembly of the European Geosciences Union](#) (EGU).

Dr. Bonnie Wolff-Boenish highlighted the importance of co-design in research addressing climate and environmental change, and the critical role social sciences play in that process.

In her presentation, she explored how digitisation opens new avenues for collaboration through data sharing and interoperability and how CESSDA ERIC, with over 50 years of

experience in social science data curation, is advancing FAIR data practices and promoting standards like DDI-CDI to support cross-disciplinary integration.

The presentation also featured examples of collaborative work across Science Clusters, including [SSHOC](#) (the Social Sciences and Humanities Open Cloud), [ENVRI](#) (European Environmental Research Infrastructures), OSCARS project, and [WorldFAIR Project](#), demonstrating how social and environmental sciences can come together through shared infrastructure and coordinated standards.

News from the ERIC Forum 2 Project

On 28–29 January, representatives from the ERICs, policymakers, and invited stakeholders convened in Rome for the ERIC Forum Annual Meeting 2025. This two-day event reviewed the progress of the ERIC Forum 2 project, included the General Assembly, and featured key

roundtable discussions with representatives from the European Commission, the EU Council Working party on Research, ESFRI and the EOSC Association.



Over 100 participants gathered at the Club University Foundation in Brussels to take part in the ERIC Forum Annual Meeting 2025.

The key themes of the conference were:

- Enhancing the engagement with stakeholders and strengthening the visibility and impact of ERICs within their broader stakeholder network.
- Improving the implementation of the ERIC Regulation and Internal Capabilities – Addressing regulatory challenges and supporting ERIC personnel upskilling.

Strengthening ERIC Regulation and Internal Capabilities

[ERIC Practical Guidelines](#). Work Package 5 is preparing deliverable 5.1, an upcoming policy paper on the sustainability of ERICs' services and operations, including commercial activities, and has contributed to the EC revision of the [European Charter for Access to Research Infrastructures](#).

During the first 18 months of the project, ERICs have also committed to promoting workshops and online seminars on central themes such as [internationalization](#) and [gender equality](#).

Future efforts will focus on developing recommendations for the green and digital transition of ERICs (Work Package 8) and creating a strategy and repository for shared services and knowledge among ERICs (Work Packages 10 and 13).

Discussions on the Future of ERICs

In addition to the project updates, the meeting in Rome offered ERICs the opportunity to engage in discussions with representatives from the European Commission, specifically Directory General (DG) Research & Innovation and DG Connect, as well as the EU Council Working Party on Research, ESFRI and EOSC Association. Three dedicated panels focused on the role of ERICs within the European research infrastructure landscape and their contributions to the EOSC Federation.

With the growing number of RIs, including ERICs, EDICs, international organizations, and the emerging technology infrastructures, the panels explored how Europe can ensure better coordination while maintaining the unique strengths of each infrastructure type.

This also raised the issue of financial sustainability in the face of growing demands and limited public funding. Participants discussed potential innovative financing models, such as private-sector involvement, co-funding mechanisms, and strategic funding allocation to ensure long-term sustainability.

Finally, the panels also addressed how to create a more balanced and inclusive European Research Area. The discussions emphasized building research capacity and making RIs more accessible across all Member States, with the aim of reducing existing disparities in research capabilities and access to resources.

Memoranda of Understanding, General Assembly and Satellite Event

The Annual Meeting for 2025 also featured the ERIC Forum General Assembly and the signing of the Memorandum of Understanding by CTAO Director General, Stuart McMuldloch, officially welcoming [CTAO as the Forum's 29th member](#).

The event was therefore an opportunity to strengthen relationships with both newly formed ERICs (for example EHRI, which is not yet officially a member of the forum) and ERICs-to-be that are still in the process of being officially recognized as part of the Forum family.

Lastly, [a satellite event, organised by Work Package 9 of the project, highlighted the need for ERICs to strengthen collaboration with Industry](#), exploring possible models of cooperation, from both policy and operational perspective.



CESSDA at the BRIDGE Conference

In March 2025, CESSDA Director Dr. Bonnie Wolff-Boenisch attended the [BRIDGE Conference](#) in Bucharest as a keynote speaker and panellist. The event focused on metadata, data stewardship and cross-domain collaboration. Several CESSDA service providers joined panel

discussions on FAIR data, interoperability and the role of research infrastructures in evidence-based policymaking.

Highlights from European Commission projects

A look back at three concluded projects

As 2024 came to a close, the projects ByCOVID, HumMingBird, and eRI mote all concluded. CESSDA, along with several of its Service Providers, was a beneficiary or partner in all three projects and supported them with everything from administrative duties to the production of deliverables.



By-Covid

Since 2021, the BY-COVID project has united 53 partners from 19 countries in a groundbreaking interdisciplinary effort to deliver open, accessible data on SARS-CoV-2 and other infectious diseases. This initiative developed key resources like the

COVID-19 Data Platform and the Pathogens Portal, improving Europe's preparedness for future pandemics and enhancing rapid response capabilities.

The CESSDA Main Office participated alongside five of its Service Providers: DANS (Netherlands), FSD (Finland), So.Da.Net/EKKE (Greece), ČSDA - (Czech Republic), and ADP (Slovenia).

HumMingBird

The HumMingBird project, an ambitious European research initiative uniting 16 partners across 10 countries, concluded with significant contributions from CESSDA partners.

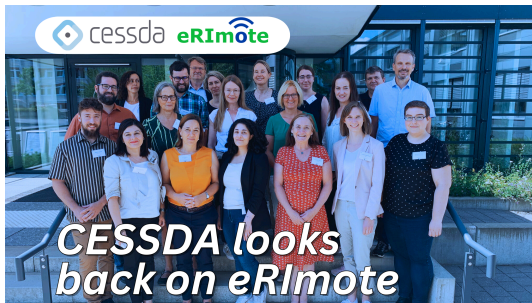
HumMingBird aimed to improve the mapping and understanding of changing migration flows while exploring innovative forecasting methods and addressing gaps in migration research. The project set out to create new approaches to migration studies, and

CESSDA partners played a critical role in data management and ensuring robust data sharing and protection, contributing to key advancements.

The CESSDA team consisted of CESSDA Main Office, So.Da.Net/EKKE (Greece) and IEN (Serbia) as Linked Third Parties.

eRImote

From June 2022 to November 2024, CESSDA participated in the eRImote project and contributed to improve the accessibility and resilience of Research Infrastructures.

The eRImote project was the first to consider solutions for digital and remote service provision across Research Infrastructures (RI) domains. The project brought together partners from the environmental, life, physical and social sciences, coordinated by [DESY](#) (Deutsches Elektronen Synchrotron). CESSDA participated alongside the Service Providers UKDS (UK) and the FORS (Switzerland).

New EC project FIDELIS launches network of TDRs

The EU-funded FIDELIS project has officially kicked off, bringing together 24 organisations from across Europe to build a network of FAIR-enabling Trustworthy Digital Repositories (TDRs). Coordinated by CSC (Finland), and with CESSDA Service Providers including FSD, GESIS, and UKDS playing key roles, the project will help harmonise standards and practices for long-term data preservation in the European Open Science Cloud (EOSC).

As part of the launch, a joint website with sister project EOSC EDEN is now live at eden-fidelis.eu, and the new FIDELIS Network is now open for provisional membership. Digital



repositories across Europe are invited to join, contribute to its design, take part in the 2025 pilot support offer, and help shape the future of trusted data infrastructures in EOSC.

I4NG workshop and events available

Infra4NextGen is a European Commission funded project which is bringing together outputs from key social science research

infrastructures to help inform the NextGenerationEU programme and European Union youth policy.

This includes online training, 17 webinars, nine workshops, three hackathons, and a short video series with demonstrations, tutorials/guides and research discussion. As a member of the Executive Board, Bonnie will help set the overall policy and budget for the Alliance.



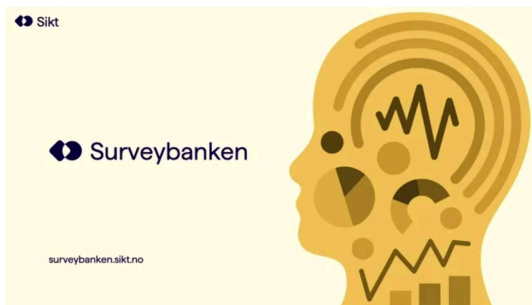

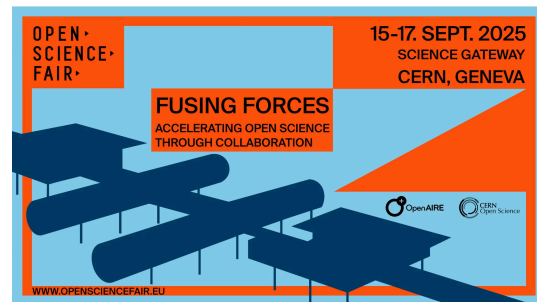
