## Resource Directory

- Main goal
  - To provide an extensive inventory into available CESSDA resources for data service building, knowledge and capacity development

#### Process

- Collection of the resources available at every CESSDA member Service Provider
- Review of the 185 reported resources and organization of the Directory
- Development of the CESSDA webpage dedicated to the Resource Directory



## Gap Analysis

#### Main goals

Collect partners' feedbacks to :

- Find out if the existing resources address the partners' needs
- Find out what kind of support is missing
- Develop future resources and support
- Improve the Resource Directory

#### Process


- Survey "Your Opinion on the Resource Directory" sent mid-September to 28 partner institutions
- 15 answers (response rate: 54%)
- Analysis of answers



## Survey – Your Opinion on the Resource Directory

- 1. Ask 3 country specific questions and assess how the resources in the directory help to answer these questions
- 2. Missing topics
- 3. Missing resources
  - Currently existing
  - Not existing yet but could be developed by CESSDA
- 4. Other comments
- → The topics raised in the answers help us to estimate the partners' main questions, problems and needs.
- → To analyse the results, we use the same categorises as for the Resource Directory.

« The idea about Resource Directory is excellent and extremely useful. We hope it will be developed extensively. »


• Good coverture (7)

All gave ideas to develop new resources





### Services & Activities

#### Most asked questions

Archiving standards, workflow, data acquisition procedures (and encouragements)

**Legal aspects** of DAS operations: contracts/licenses, GDPR and other policies, data ownership

**Policies and plans**: preservation policy, continuity/disaster plans

#### Resources to develop

- A guide/strategy for encouraging sharing primary data
- Guidance on data archiving activities where the knowledge is systematised and can be generally applied
- Examples of activities, workflows, policies, deposit and user contracts from working archives

Technical solutions without funding and/or IT expertise



## Staffing, Management & Financing

Most asked questions



**Funding**: How to get funding and secure it for the long term? How to overcome the lack of (national) funding?



- **Internal structure** of a DAS: how many employees and with which professional requirements?
- **Capacity building**: How to overcome the lack of staff with capacities on establishing and maintaining a DAS / with IT expertise?

#### 4.1 Roadmap for Preservation and Curation in the SSH

Create and maintain **short - and long-term business and financial plans and a funding model**. Monitor and analyze financial risks, benefits, investments and expenditures. Carry out **marketing and promotional activities** suitable for the repository's needs. Maintain a residual fund, if possible, to cover for situations of financial shortfalls.

Concerning human resources, maintain a good level of expertise by actively supporting training and development and internal and external as well as multidisciplinary collaborations.



### Staffing, Management & Financing

#### **Cost-Benefit Advocacy Toolkit**

This toolkit is comprised of:

- A User Guide;
- Three Factsheets (Benefits, Costs, and Return on Investment);
- Four Case Studies from Social Science Data Archives (ADP in Slovenia, FSD in Finland, LiDA in Lithuania, and UKDS in the UK);
- Two Worksheets (the Archive Development Canvas, and the Benefits Summary for a Data Archive).
