History of Trust workshops/ trainings

Both existing and aspiring CESSDA SP participated, and new initiatives

- 1. Focus on CESSDA Members:
- → support aquiring Trust Seal through selfassessment, peer assesment and consultations
- 2. Focus on new country service providers in a Widening context:
- →CTS Guidance can help planning new data service institutions
- → Gap analysis following CTS and Maturity self-assessments

- » CESSDA Expert Seminar 2015, The Hague, The Netherlands
- Trust working group established
- » Zagreb SEEDS Workshop (November 2017)

Trust workshops 2013 and Expert seminar 2015

Workshop 2013 results:

- » Self Assessment by each SP, in total 14
- » Self \rightarrow Reviewer \rightarrow Expert

Points of attention:

- » Documentation missing, especially in English
- » "Work in progress": how far is the work really?

Expert seminar 2015:

- » TrustWorking Group established based on the "CESSDA Workplan Proposal,
- » Trust is a central issue in CESSDA
- Professional excellence by following standards
- Monitoring compliance to the standards
- Training as support
- Monitoring CESSDA SP's Annex 2 obligations

DSA - Data Seal of Approval was one of the topics of SEEDS Training workshop

Some useful tips and motivations given:

- » For aspiring new archives DSA is a guideline and support for building up the archive.
- » For existing archives it enables evaluation of established procedures and processes.
- » It is also one of the prerequisites for CESSDA membership.
- Recommended creation of documents lists (available, not yet completed and still needed)
- » Types of documents (policies, contracts, general information, technical ...)

DSA - Data Seal of Approval / lead by Natascha Schumann

- » Explaining the concept of basic, extended and formal certification (CTS, Nestor, ISO16363)
- » DSA was developed in 2008 by DANS
- Working Group DSA-WDS was established in 2012
- » CTS established in 2017: emphasis is on documented procedures and plans

CESSDA SaW "Trust" workshops 2016, 2017

Focus:

- » the new Common Requirements from DSA/WDS and an overview of the changes
- each SP identified a contact person for trust and certification issues
- » working group have undertaken to review all test assessment and give feedback to the participants
- » gap analysis based on all the test self-assessments
- » With regard to compliance and the timing of a TDR application, a number of service providers stressed their uncertain future and funding
- » Others discussed the resource implications of preparing and making public the evidence required

Gap analysis, 2017

15 participants submitted a test selfassessment statement and supporting evidence

Each submission was reviewed by two expert members of the CESSDA Trust group

Some institutions did not use the test assessment at all, mostly for reasons of lacking resources, funding, support from ministry... » technical infrastructure and security continuity of access, documented procedures and preservation plans.

- highest scores mission/scope of the repository,
- » expert guidance
- » confidentiality / ethics

Comments most often made by reviewers

R3: Continuity of access

- » Lacking description of plans and procedures in case no formal succession plan is in place
- » Agreements or other documents to provide evidence
- » Preconditions to hand over data to other institutions

- » R4: Confidentiality/Ethics
- » Missing links to documents/procedures
- » Possible effects of the new EU data protection regulation
- Handling of data with disclosure risk to be described, also for internal data management
- » Description of procedures would be helpful


- » Skills of staff
- » Breach policy

Organisational Infrastructure DAS self-assessment by size of organisation (2017); CESSDA membership makes difference in



CESSDA membership makes difference in particular for the organisational viability.

Examples includes agreements with the organisations with the national reputation: National libraries, Academies of science, and funding organisations.

In some cases, special task forces are foreseen, to manage technical and organisational aspect of a succession

A succession plan includes the key representatives of (former) organisations and external stakeholders into the membership of the task force.
